**YOU MUST BRING THESE ADDITIONAL ITEMS TO THE FOLLOWING CLINICS:**

- FINAL DISSOLUTION BY DEFAULT**  **DEFAULT PARENTAGE:** Must Bring your Petition, Proof of Service, 9 Stamps and 3 envelopes (2 half manila and one standard).
- REQUEST FOR ORDERS: CUSTODY AND VISITATION:** Custody/Visitation Only. Must bring a Copy of the Prior Order.
- FINAL DISSOLUTION BY AGREEMENT:** Must pre-register for this class. Bring 2 envelopes and 8 stamps.  **JUDGMENT AFTER COURT TRIAL:** Must bring 9 Stamps and 3 half manila envelopes.
- GUARDIANSHIP CLINIC:** Bring Completed Guardianship Questionnaire for each proposed guardian.  **FINDINGS AND ORDER AFTER HEARING:** Must bring 3 Stamps and 1 envelope.
