- ☐ FINAL DISSOLUTION BY DEFAULT ☐ DEFAULT PARENTAGE: Must Bring your Petition, Proof of Service, 9 Stamps and 3 envelopes (2 half manila and one standard).
- ☐ REQUEST FOR ORDERS: CUSTODY AND VISITATION: Custody/Visitation Only. Must bring a Copy of the Prior Order.
- ☐ FINAL DISSOLUTION BY AGREEMENT: Must pre-register for this class. Bring 2 envelopes and 8 stamps. ☐ JUDGMENT AFTER COURT TRIAL: Must bring 9 Stamps and 3 half manila envelopes.
- ☐ GUARDIANSHIP CLINIC: Bring Completed Guardianship Questionnaire for each proposed guardian. ☐ FINDINGS AND ORDER AFTER HEARING: Must bring 3 Stamps and 1 envelope.
