I HAVE FILED THE FOLLOWING DOCUMENTS LISTED BELOW:

- FL-150 Income and Expense Declaration**
- FL-140 Declaration of Disclosure (Do not file with the court but serve the other party with a copy)**
- FL-141 Declaration Regarding Service of Declaration**
- FL-160 Property Declaration (Community Property and Separate Property)**

The dissolution Petition has been filed and served on the Respondent. Respondent has filed a Response with the court, so the default process cannot go forward. Now all issues need to be settled. One way is to reach an agreement, or stipulation, between the Petitioner and Respondent. If that option is not available, the matter will likely need to be set for trial.

The At-Issue Memorandum, when completed, advises the court and the other party that you are ready for trial.

1. Complete the At-Issue Memorandum form appropriately. Do not fill out page 2, yet.
2. Make 2 copies of the completed form.
3. Have someone else, **not you**, mail one copy to the other party in the case prior to filing it with the court. Have that same person complete the Proof of Service by Mail (Page 2) on the back of the original At-Issue Memorandum (be sure they sign it).
4. File the original At-Issue Memorandum with the completed Proof of Service by Mail (Page 2) with the Court Clerk.
5. Keep a copy for yourself.
6. You must also serve a Declaration of Disclosure (**form FL-140**) on the other party. You may serve the other party at the same time you are serving the At-Issue Memorandum.
7. The Clerk will issue a minute order that sets the date and time of the trial, and will mail a copy of it to Petitioner and Respondent.
